Re: Australian Recreational Therapy Association Application for Ordinary Membership with AHPA

Re: Outcome of Membership Application

Thank you for your application to join Allied Health Professions Australia (AHPA) as an Ordinary (Full) Member. We greatly appreciate the patience and understanding demonstrated by both you and your Board throughout this process, particularly in light of the delay in finalising our response.

After careful consideration, the AHPA Board has made the decision to decline your application. This decision is based on two primary factors:

1. Definition of Allied Health

As you may be aware, the Office of the Chief Allied Health Officer is currently in the process of developing a comprehensive definition of allied health professions. This initiative is expected to lead to an official list of recognised allied health professions, which may subsequently impact our membership categories and allied health policy. Given that this important work is ongoing, the AHPA Board has decided to seek further information and potential implications of this process to inform admittance of emerging professions. The pending federal election will unfortunately extend the timeline until greater clarity is achieved.

2. ARTA Membership Qualifications

The Board has noted that, of the total ARTA membership of 357 (excluding students), only 146 members currently hold qualifications at AQF7 or above. As a result, the majority of your members possess qualifications at the diploma or certificate level. While the Board acknowledges the potential of Recreational Therapy as an emerging profession, it remains committed to maintaining AQF7 as the minimum qualification requirement for full

membership. Professions with a significant majority membership below this threshold, even if non-voting members, do not meet this standard.

We recognise and value the significant growth potential of Recreational Therapy and the role your profession plays in Australia's health system. We remain open to revisiting this matter when the significant majority of your profession hold an AQF7 or above qualification, or if changes occur once the Office of the Chief Allied Health Officer has completed its work on the definition of allied health.

Furthermore, before applying for Ordinary membership in the future, it is important to note that AHPA would likely need to differentiate membership based on the educational qualifications of your members. We do not anticipate that any Commonwealth definition of allied health professions will alter AHPA's position regarding the inclusion of professionals with qualifications below AQF7, nor its ability to advocate for funding programs or the recognition of allied health professionals at varying qualification levels.

We understand that this outcome may not align with the expectations of you or your Board, and we sincerely appreciate the time and effort you have dedicated to this application. We will be in touch with you as soon as further developments arise in relation to the definition of allied health.

Thank you again for your understanding and commitment to advancing the sector.

Presentation formats

Leisure Bite – big ideas in a small window (15 minutes)

Leisure Labs – deep dive into recreation innovation (45 minutes)

Guidelines will be provided to those authors whose abstracts are accepted and these will vary depending on the presentation type.

Abstract Submission Details

Abstracts should be a summary of the material that is to be presented at the conference:

Microsoft Word format, Arial 12pt font or similar, and single spaced

Abstract must be clearly written in English and a maximum of **300** words.

Preferred presentation format

Author name/s, qualification, or course of study

Position and employment details

Contact details including phone and email address.

The ARTA Conference Committee encourages submissions from Aboriginal and Torres Strait Islander allied health professionals, students, researchers and educators, Aboriginal and Torres Strait Islander health and community workers.

Selection and notification

Abstracts will be assessed for originality, quality, relevance and professional interest. The conference committee is keen to ensure that new graduates/early career therapists as well as experienced presenters are included in the conference program.

Receipt of abstracts will be confirmed by an acknowledgement email.

Abstracts will form part of the conference program and distributed to delegates prior to the conference. Some minor edits may be made, if necessary to enhance readability for the conference program.
